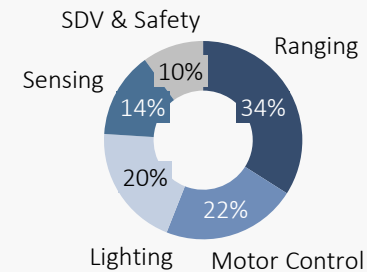

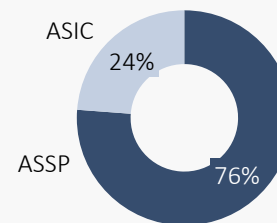

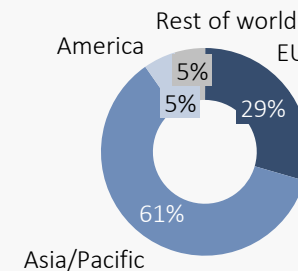

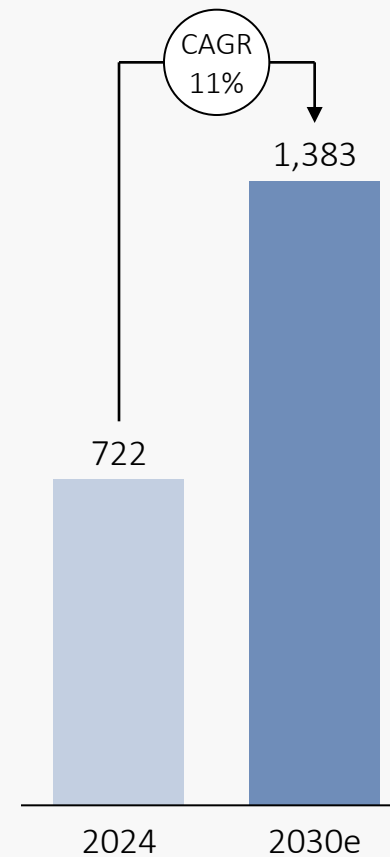

Semiconductor Content Growth Drivers

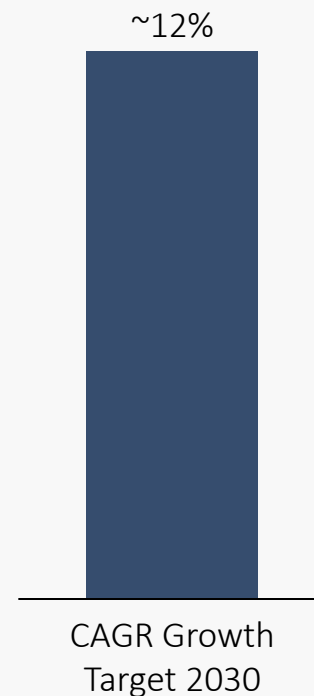


Semiconductor Content per Vehicle (in USD)

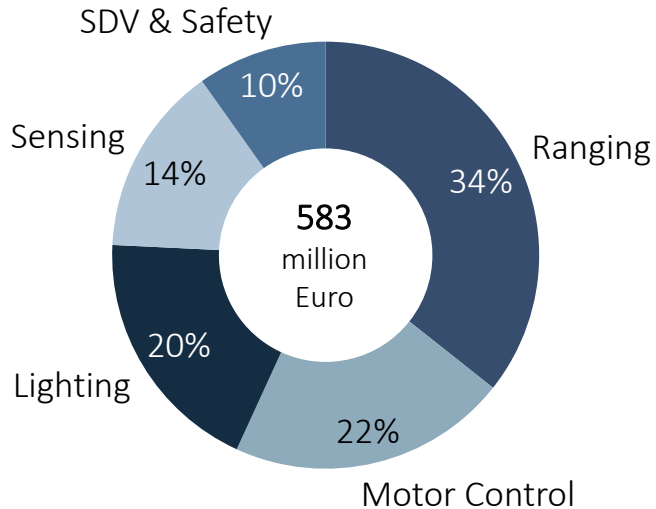

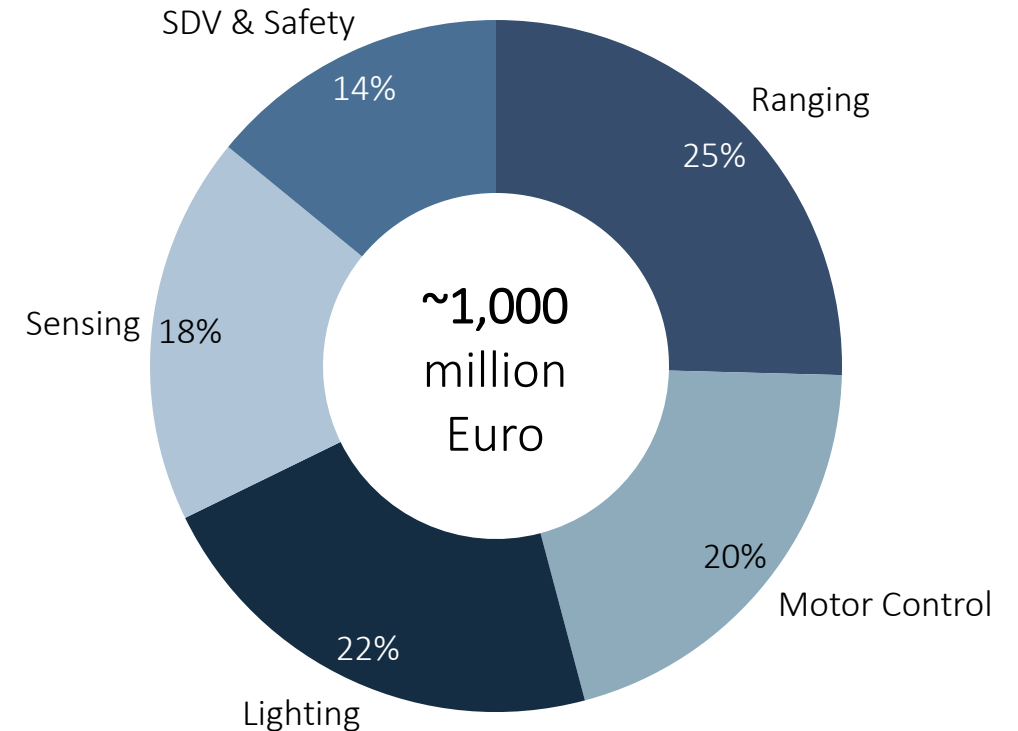
Elmos Sales by Segment

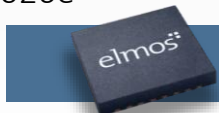

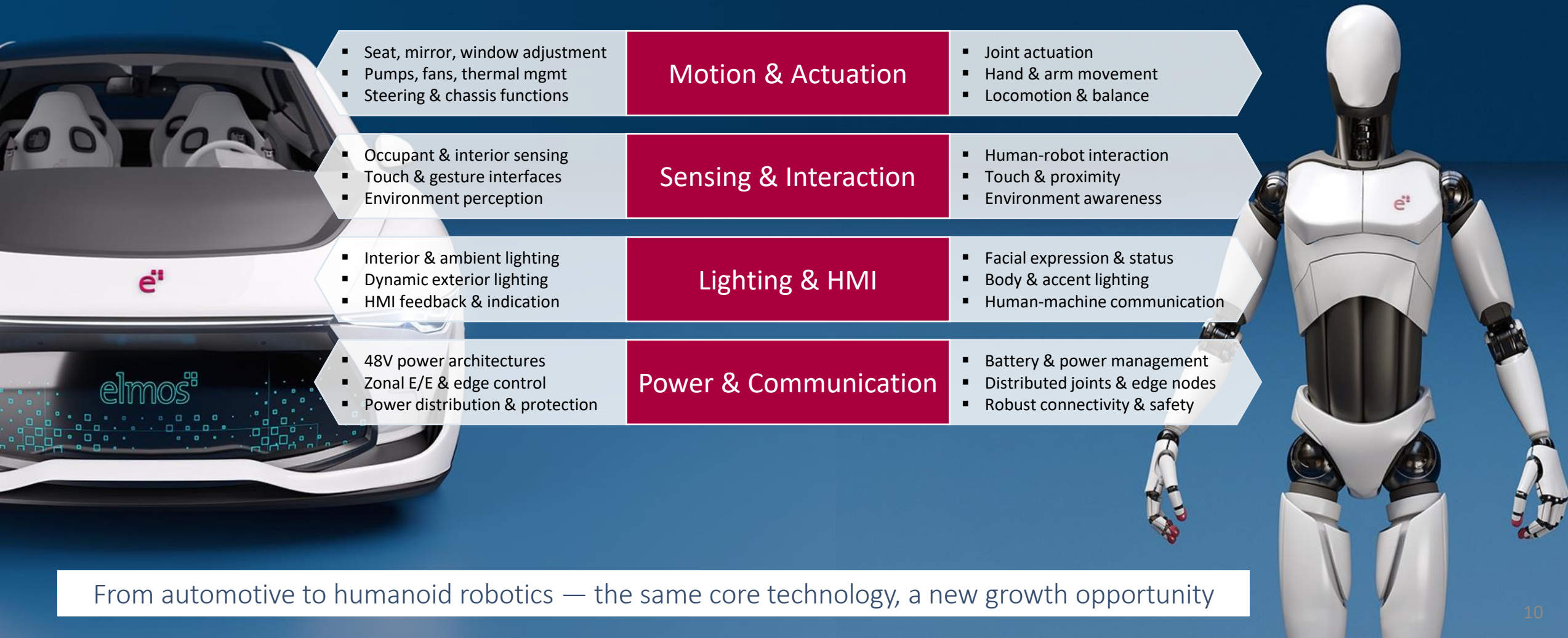

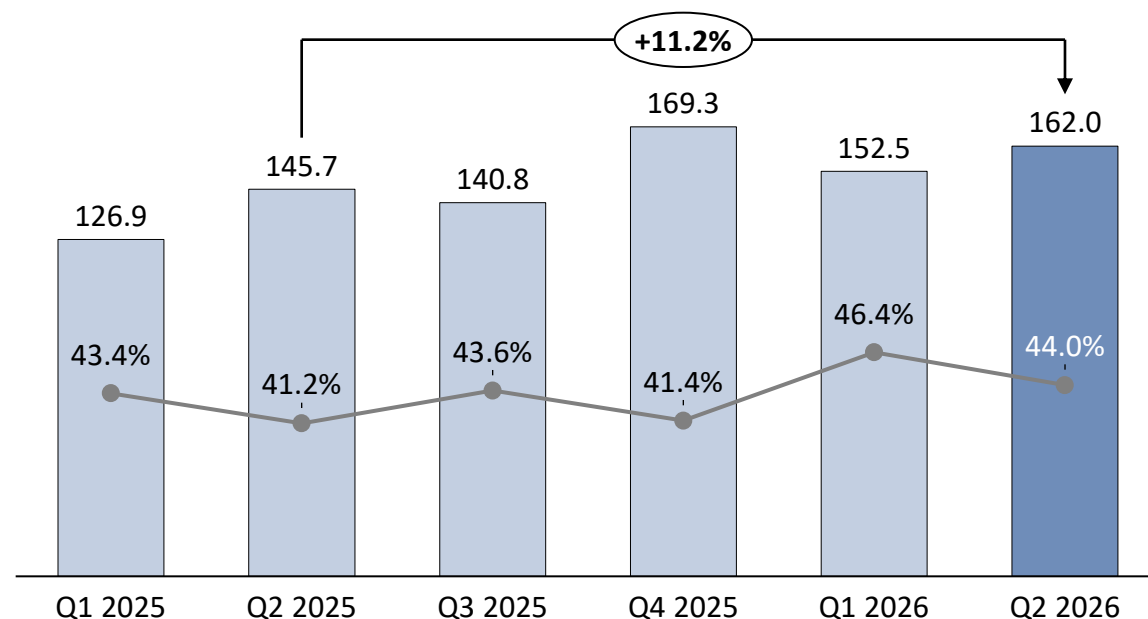

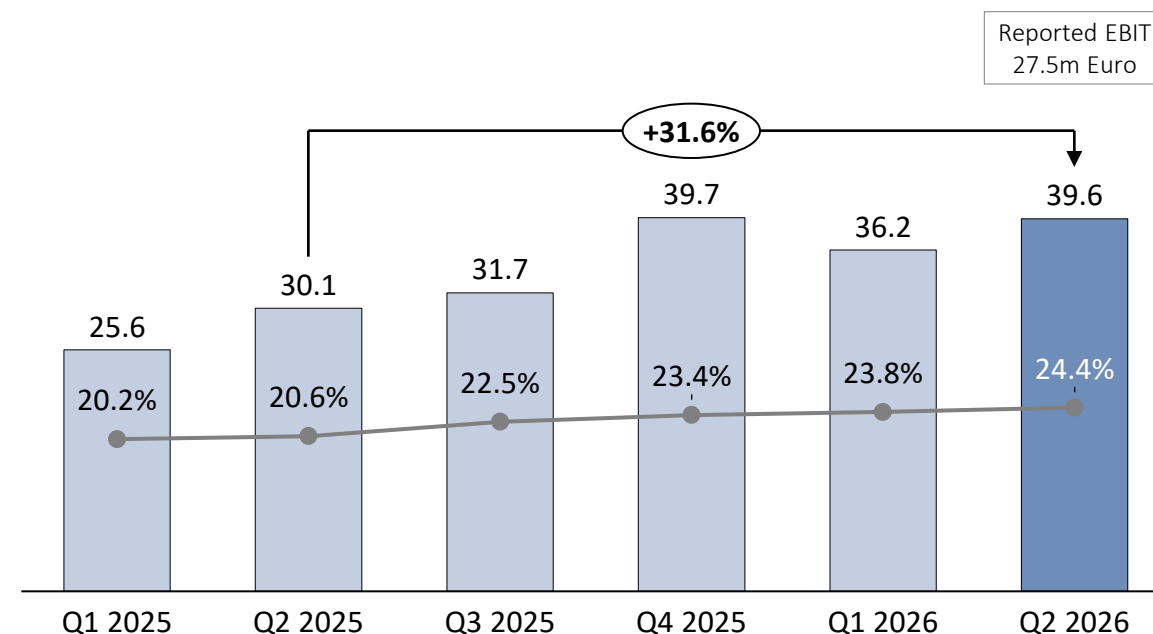
Sales and EBIT

Quarterly Sales (in million Euro) & Gross Margin (in %)



- Q2 2026 sales increased to 162.0 million Euro or +11.2% YoY with a gross margin of 44.0%.
- End of inventory adjustments in the automotive semiconductor industry leads to increasing customer orders.
- China remains a strong growth driver, product ramps in Japan and Korea and a slightly better demand across Europe and the Americas supported the sales development in the first half year 2026.

Quarterly Operating¹ EBIT (in million Euro) & Operating¹ EBIT Margin (in %)

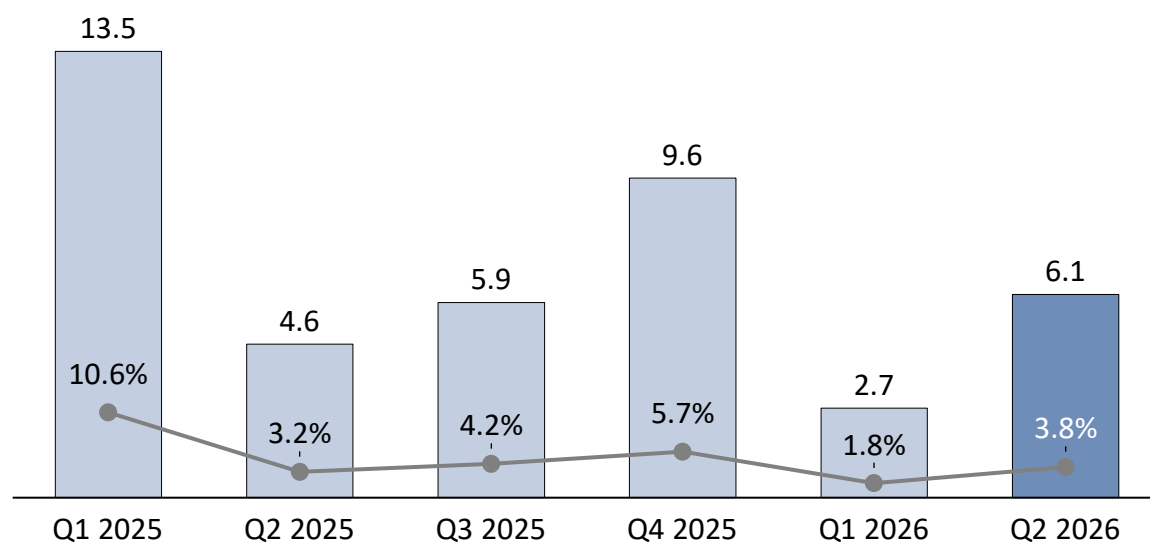


- Operating¹ EBIT improved significantly to 39.6 million Euro with an EBIT margin of 24.4% in Q2 2026.
- In addition to higher sales and the results of our cost optimization and efficiency programs on the one hand, earnings in the first half of the year were also influenced by rising costs for materials and supplier services on the other.

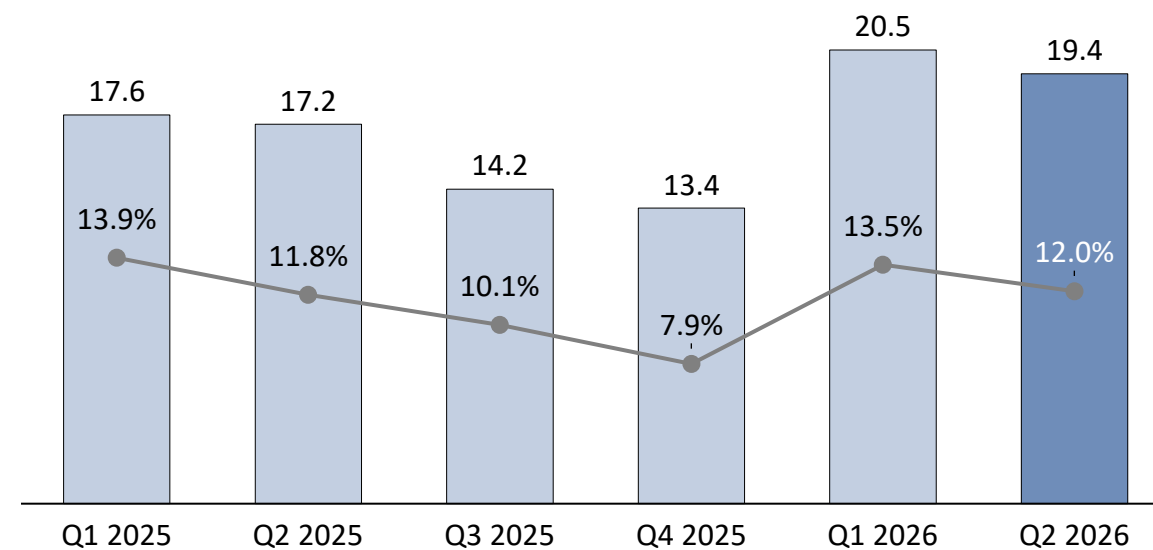
CAPEX and R&D Expenses

- Capital expenditures amounted to **6.1 million Euro or 3.8% of sales** in Q2 2026 and continue to be on a low level.

R&D Expenses (in million Euro & in % of Sales)

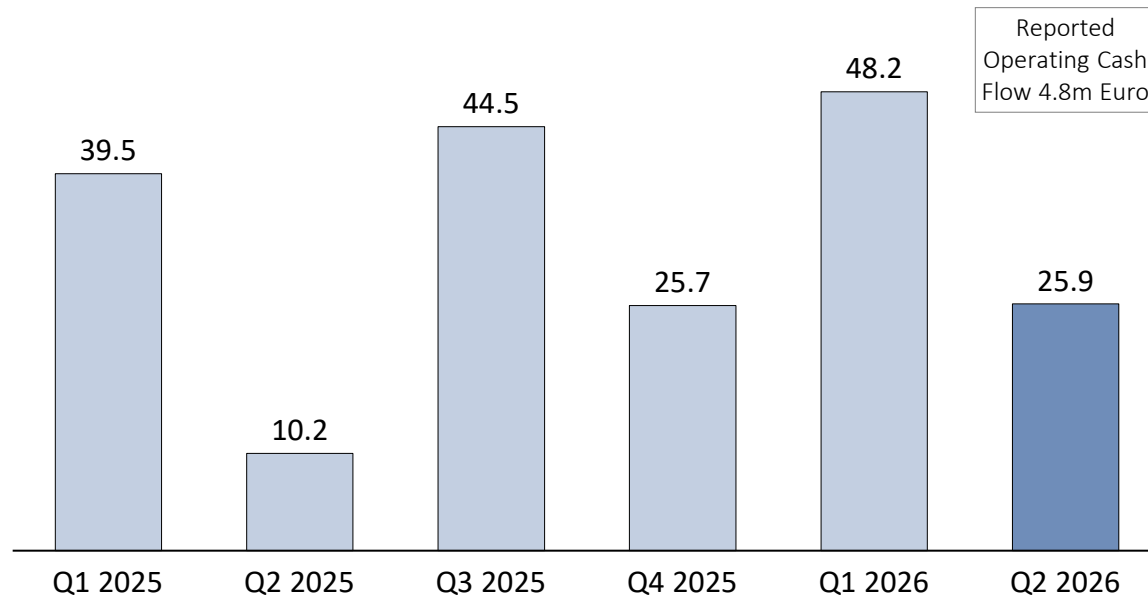


- R&D expenses stood at **19.4 million Euro or 12.0% of sales** in the second quarter 2026.
- We are **expanding our global R&D capacities** with a local R&D center in China as part of our China localization strategy and a new R&D location in the Czech Republic.

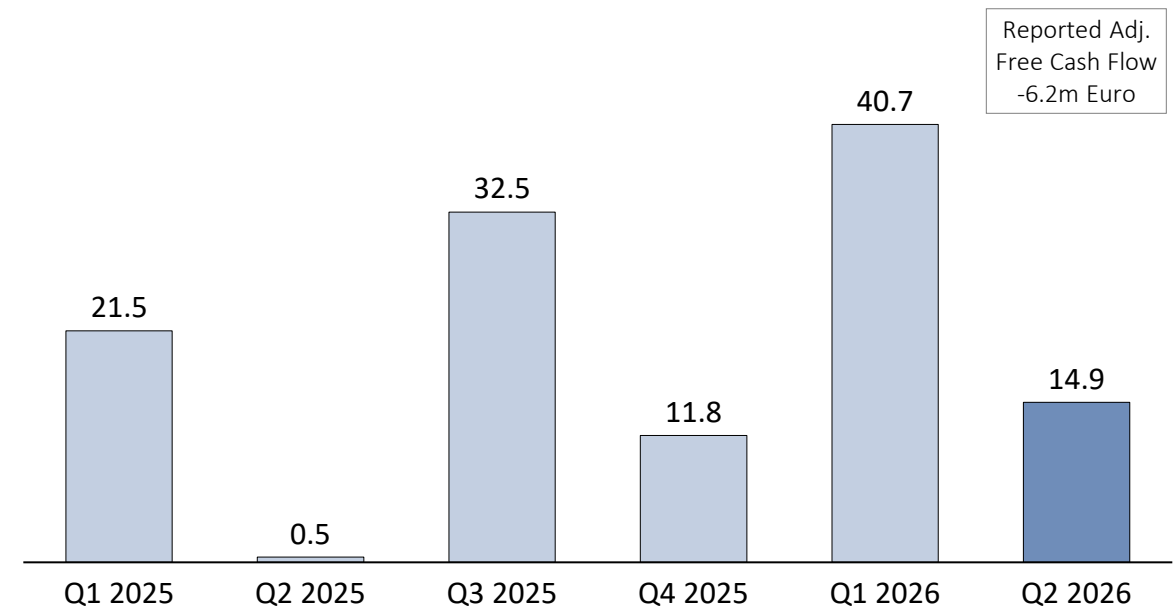
Cash Flow

- Q2 2026 **adjusted¹ cash flow from operations** totaled **25.9 million Euro**.
- The development vs. Q1 2026 was mainly due to higher trade receivables resulting in **increasing working capital**.

Operating¹ Adjusted Free Cash Flow² (in million Euro)



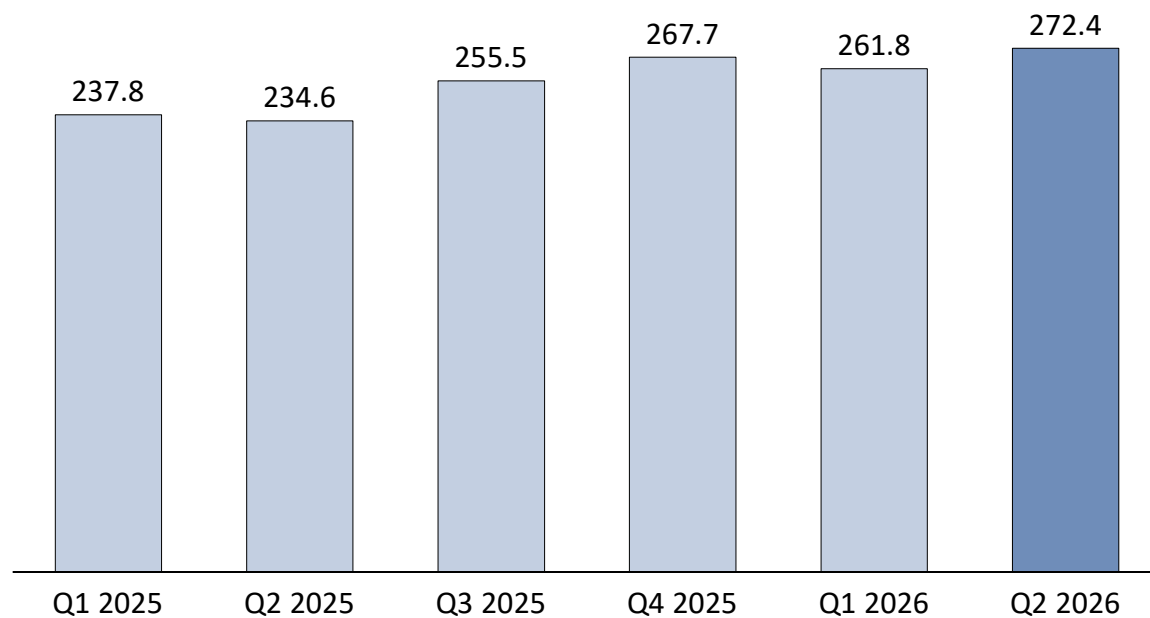
- Due to low CAPEX and the reduction in working capital **operating adjusted free cash flow** amounted to **14.9 million Euro** or **9.2% of sales** in Q2 2026.

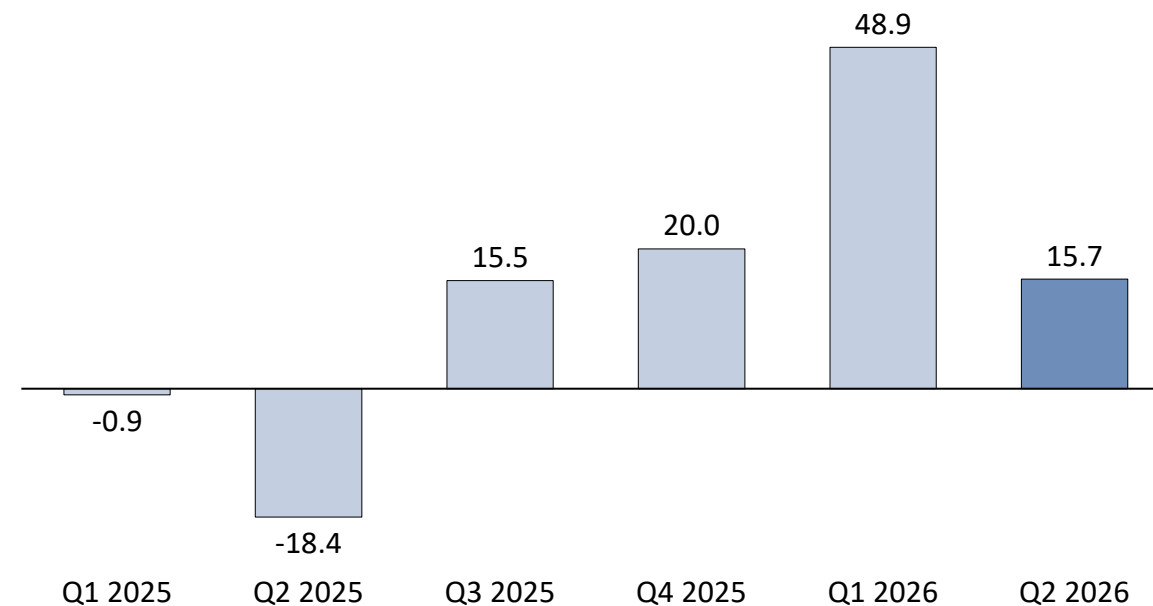
Working Capital and Net Cash/Debt

- Working capital increased to **272.4 million Euro** at the end of Q2 2026 mainly due to higher trade receivables.

Net Cash/Debt (in million Euro, at the End of the Quarter)



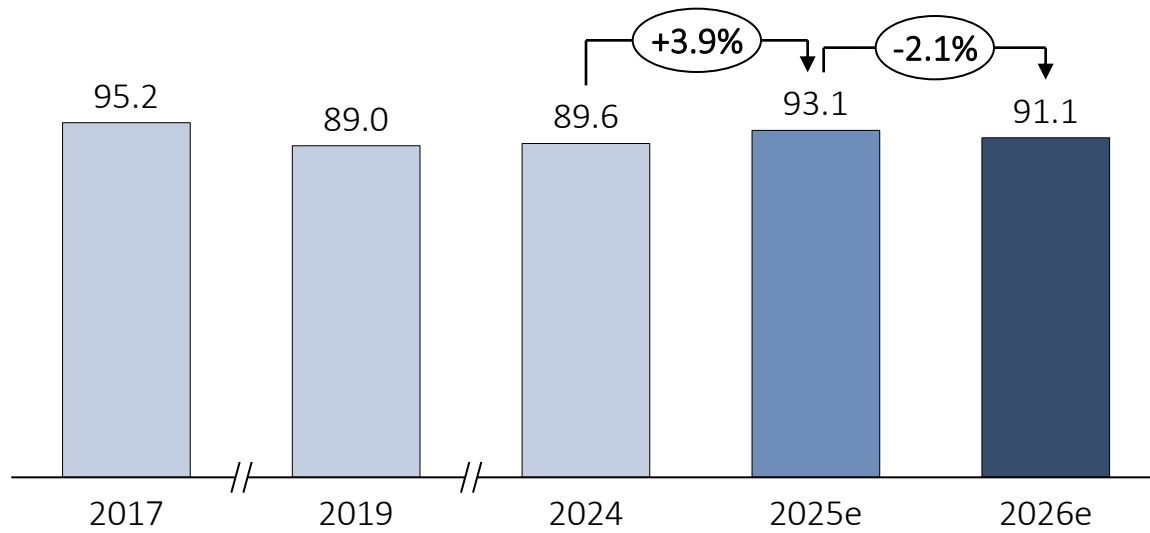
- After the dividend payment in Q2 2026, the **net cash position** of Elmos decreased to **15.7 million Euro** at the end of June 2026.
- Total payout to shareholders of 35.7 million Euro** in the first half of 2026, consisting of a share buyback (-10.0 million Euro) and the dividend payment (-25.7 million Euro).

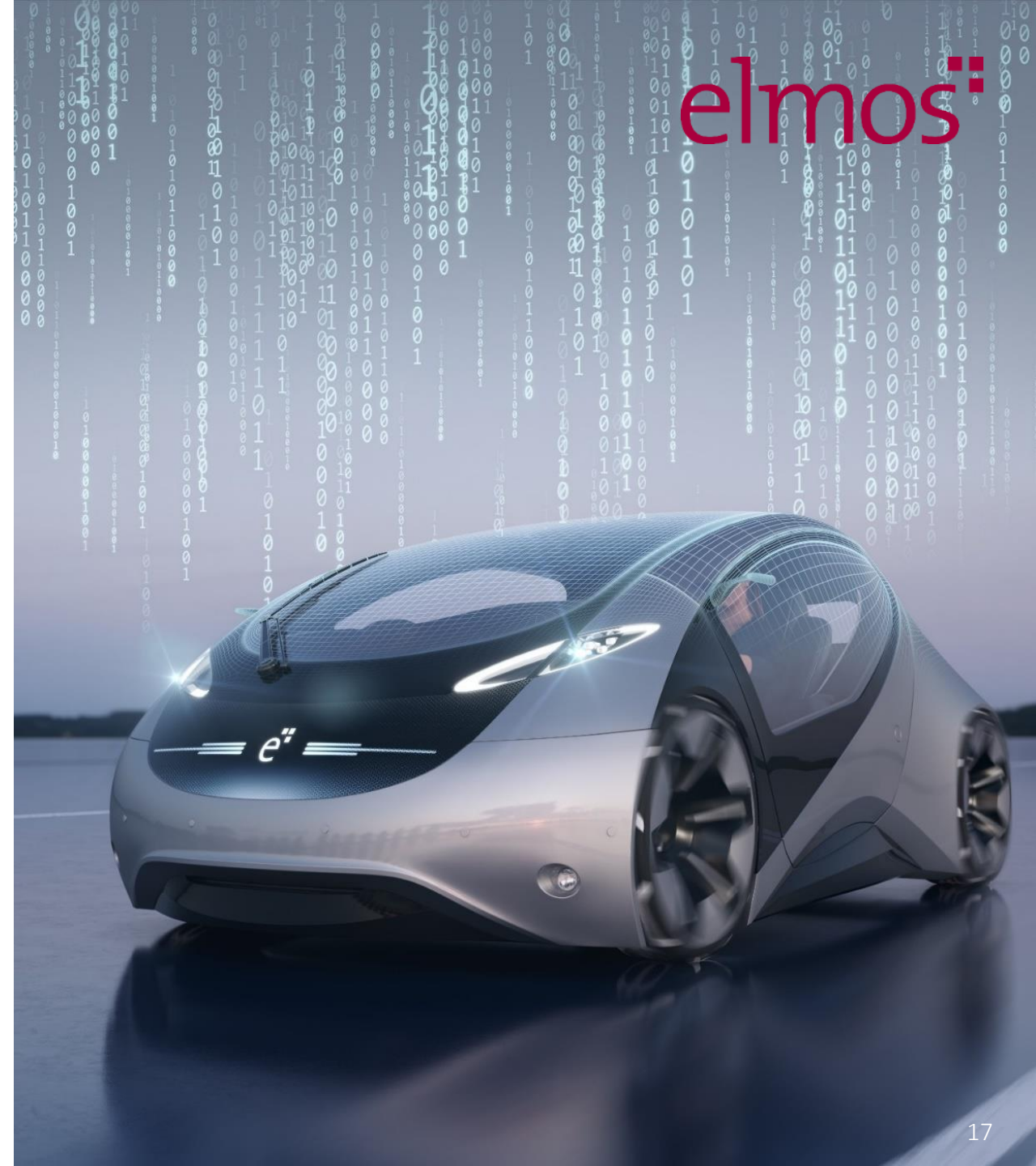

Notes to guidance 2026:

Besides current business performance and the order situation, the guidance is also based on the expectations and assumptions regarding general economic development and specific industry and market development. Current expectations may be influenced in particular by geopolitical events, intensified sanctions and trade restrictions as well as economic, sector and market-specific developments and cost fluctuations.

Note on operating performance indicators

As announced in May 2026, following the almost complete cancellation of the Company's treasury shares, share-based compensation programs are, until further notice, settled exclusively in cash. IFRS accounting effects resulting from the transition to cash-settled share-based compensation are excluded from operating EBIT, while cash effects arising from the cash settlement of such awards are excluded from operating adjusted free cash flow.

Accordingly, the full-year guidance for the EBIT margin and adjusted free cash flow has, as previously communicated in May 2026, been prepared exclusively on the basis of operating KPIs.

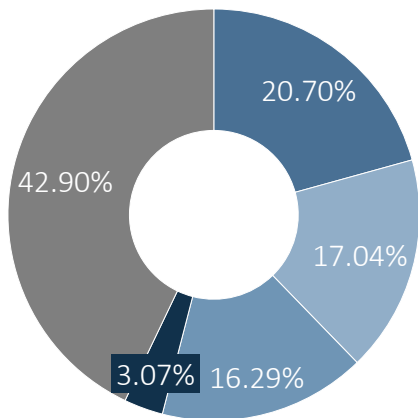


Shareholder Structure set for Long-term Perspective with increased Free Float

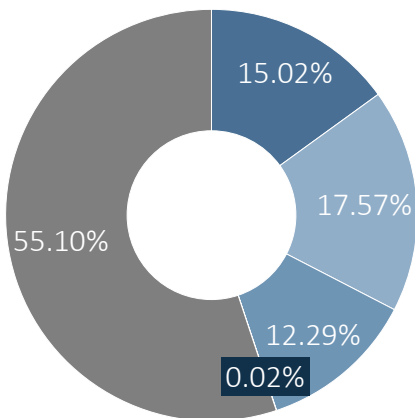

Placement of 1.86 million existing shares by two anchor shareholders

Weyer Beteiligungsgesellschaft mbH and ZOE-VVG GmbH, two anchor shareholders of Elmos, successfully placed 1.86 million existing shares on a pro-rata basis, corresponding to 10.5% of the current share capital in Elmos Semiconductor SE to institutional investors at a placement price of 176 Euro per share on May 11, 2026.

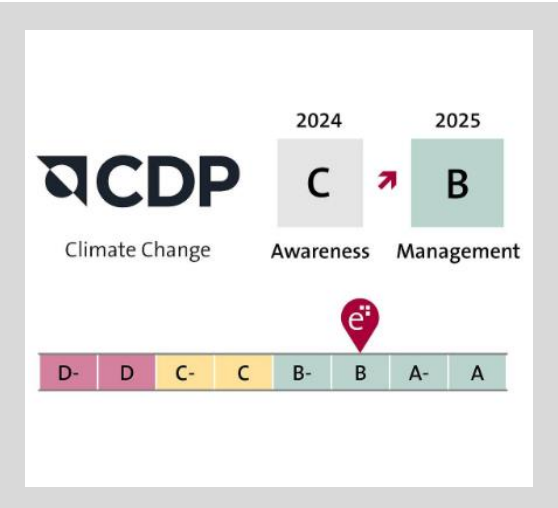
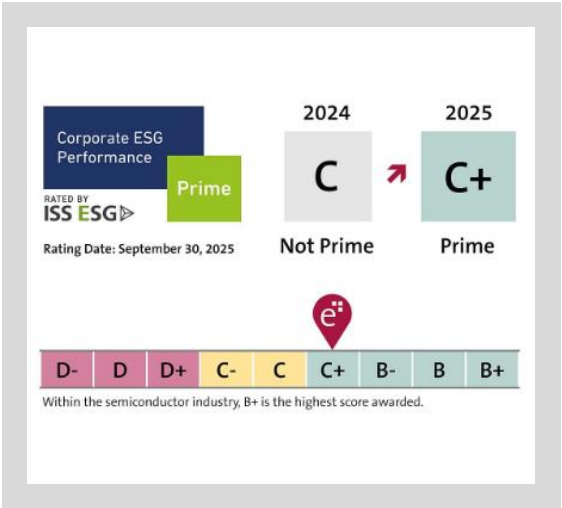
The placement increased the free float of the Elmos shares by 20%. After the transaction and the cancellation of treasury shares (June 8, 2026), free float is around 55% and the three anchor shareholders continue to combine around 45% of the share capital, providing a continued stable ownership structure.

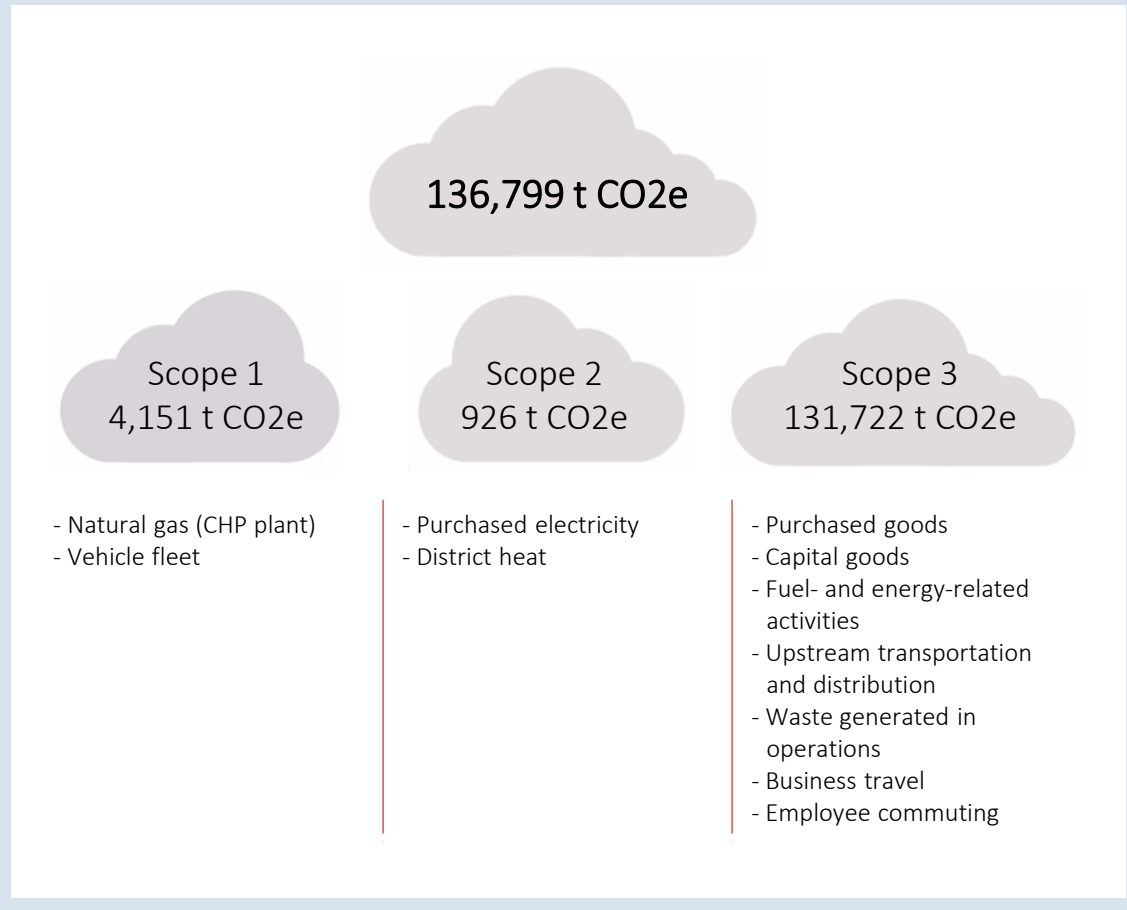

Elmos Corporate Carbon Footprint 2025

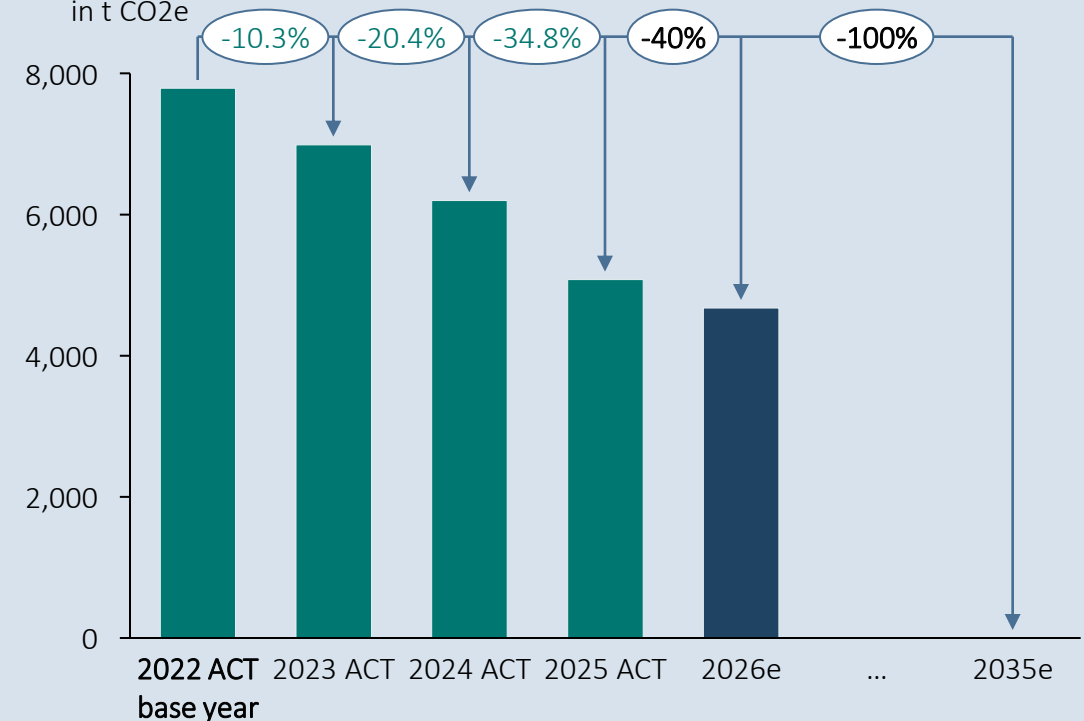
